The Company had availed the e-voting facility offered by National Securities Depository Limited (NSDL) for conducting remote e-voting by the Shareholders of the Company.

The Shareholders of the Company holding shares as on the 'cut-off' date i.e., Friday, 7<sup>th</sup> November, 2025 were entitled to vote on the resolution as contained in the Notice.

The voting period for remote e-voting commenced on Saturday, 27<sup>th</sup> December, 2025 at 09.00 A.M. IST and ends on Sunday, 25<sup>th</sup> January, 2026 at 05.00 P.M. The e-voting module was disabled by NSDL thereafter.
